MUNICIPAL PUMPING POWER SERVICE RATE SCHEDULE MP-23

I. AVAILABILITY

At any point on existing facilities having adequate capacity and suitable voltage for delivery of service from the Company's interconnected transmission system.

II. APPLICATION

To electric service for the operation of municipally owned water supply and sewage pumping plants, where all such plants are completely electrified and are operated by service of Company, except that other power sources may be maintained for standby or insurance purposes only. All service is supplied through one kilowatt-hour meter at one point of delivery.

This rate for public water supply and sewage disposal pumping service is offered to all municipalities in which Company does a general retail business, as Company's contribution to the securing of adequate fire protection service for its own property and that of its customers, on whom Company depends for its revenue.

Applicable to flood control and drainage pumping only when such installations are operated by a municipality taking service for its water distribution system under this Schedule.

Not applicable to temporary, breakdown, standby, supplementary, resale, or shared service.

III. CHARACTER OF SERVICE

Single or three phase, 60 cycles, and at any one standard voltage required by Customer, as described in Company's Standards For Electrical Installations, except that when service to fire pumps is at distribution voltage, Company will make one transformation to another motor voltage.

IV. NET MONTHLY RATE**A. RATE**

\$0.095007	per kWh for the first 800 kWh
\$0.082276	per kWh for the next 160 kWh per kW of Demand but not less than 3,200 kWh
\$0.075745	per kWh for the next 10,000 kWh
\$0.060562	per kWh for all additional kWh

B. MINIMUM BILL

\$3.45 per kW of 50% of Demand, except that Customer may request that service to flood control or other emergency equipment be discontinued in months during which no service is required, in which event the minimum kW specified in the Agreement For Service shall be waived.

C. ADJUSTMENTS

First - Plus or minus an amount determined in accordance with Company's effective Energy Cost Recovery Rider on file with the Mississippi Public Service Commission.

Second - Plus or minus a percentage adjustment on the pre-tax billing sufficient to compensate Company for any increase in income taxes above the 1993 level or to reduce Customer's billing to adjust for any decrease in any effective income tax rates.

Upon any change in the effective rates of income taxes the Company will file within 30 days the percentage adjustment to be applied for the remainder of the year based on operations for the prior calendar year. Subsequently the percentage adjustment to be applied during a year will be filed with the Commission prior to February 1 of each year and will be based on the prior calendar year's operations. The adjustment will be such percentage as may be necessary to obtain the same after-tax income under the effective tax rates as would have been realized under income tax rates in effect for the year 1993 without this income tax adjustment.

Third - Plus the applicable proportionate part of any directly allocable tax, impost, or assessment imposed or levied by any governmental authority, which is assessed or levied against the Company or directly affects the Company's cost of operation and which the Company is legally obligated to pay on the basis of meters, customers, or rates of, or revenue from electric power and energy or service sold, or on the volume of the energy generated, transported, purchased for sale, or sold, or on any other basis where direct allocation is possible.

V. MEASURED LOAD

The average kW supplied during the fifteen-minute period of customer's greatest use during the current month, but not less than the higher of: (1) the minimum kW specified in the Agreement For Service, or (2) 3 kW.

VI. DEMAND

Beginning with bills rendered during the October 2023 billing month, "*Demand*" shall be the highest kW of Measured Load established during the immediately preceding 24-month rolling period, or the maximum kW specified in the Agreement For Service, whichever is the greater. In the event the instantaneous load of Customer's installation exceeds the Measured Load by an unusual amount, such instantaneous load may be taken as the Demand.

Demands of fire or flood protection pumps during times of fire, flood, or test will be waived for billing purposes provided:

- (1) that such demands are limited to Company's off-peak periods so far as emergencies will permit, and
- (2) that customer has notified the Company within five days after any use of such pumps during a fire, flood, or test, of the time and duration of such demands.

VII. CONTRACT PERIOD

Not less than five years, and for like periods thereafter, in accordance with Company's Agreement For Service.

VIII. RESERVATION

Subject to orders of regulatory authorities having jurisdiction and to the provisions of Company's Service Policy currently on file with the Mississippi Public Service Commission.
