SEASONAL AND INTERMITTENT SERVICE RIDER SCHEDULE SI-16

I. AVAILABILITY

At points on existing Facilities having adequate capacity and suitable voltage for delivery of service or on extended facilities constructed by agreement under the terms hereof for delivery of service from the Company's interconnected system.

II. APPLICATION

To electric service billed under the General Lighting and Power (GS) rate schedule when service is required only seasonally or intermittently during certain months of the year with or without some lesser service requirements during other months.

Not applicable to standby, supplementary, breakdown, resale, or shared service.

All provisions of Company's applicable rate schedule apply, except as modified herein.

III. BILLING

In accordance with the terms of the applicable rate schedule except that (1) the monthly bill for the electric service actually used during the current month shall be based on the kW of Measured Load established during the current month, (2) the Minimum Monthly Bill for such services actually used shall be \$3.37 per kW of Measured Load established during the current month, and (3) the Facilities Charge set forth below shall become payable in the manner provided.

Bills shall be computed each month on the basis of the maximum Measured Load set at any time during the monthly billing period, and shall be prorated for a period of less than one month only at the beginning and on termination of the Agreement For Service.

Billing will be continuous throughout the contract year unless service is temporarily disconnected after the end of the Operating Season at the request of Customer, in which event there will be no billing (other than Facilities Charge) for the period of disconnection.

IV. FACILITIES CHARGE

(1) In addition to the amount computed under the Billing provisions above, a Facilities Charge of \$10.66 per year for each kW of Capacity Requirement shall be added to the net monthly billing before application of the rate schedule adjustments. This amount is due and payable on the first month in each contract year. At Customer's option such payment may be paid as follows:

(a) On the first month of Customer's Operating Season and at 12 months intervals thereafter.

(b) Four monthly installments beginning with the first month of Customer's Operating Season. Where Customer's Operating Season is other than four consecutive months, the facilities charge may, at Company's option, be spread in equal monthly installments over Customer's normal Operating Season.

(2) A credit of \$0.89 will be allowed against Facilities Charges paid in the contract year for each kW of Measured Load paid for by Customer during any month of the contract year.

(3) In event the total cost new of all additional facilities installed to serve Customer exceeds \$43.29 per kW of Capacity Requirement of Customer, a Facilities Charge equal to 18% per year of such total cost shall be substituted for the charges set forth under (1) above.

(4) Customer agrees to the following:

(a) Customer's Operating Season will be the months of _____ through _____.

(b) Customer's payment for facilities will be made per (1) _____ (a or b as above) or per (3) above based on a total cost of _____ but not less than the Facilities Charge set out in (1).

V. OPERATING SEASON

Any four or more consecutive months beginning not later than the end of the sixth month of the contract year. Service may be disconnected at the end of the Operating Season at the request of Customer.

VI. CAPACITY REQUIREMENT

The highest kW of Measured Load established during the contract year or previously established, or the maximum kW specified in the Agreement For Service, whichever is the greater. In event the instantaneous load of Customer's installation exceeds the Measured Load by more than fifty percent, such instantaneous load may be taken as Capacity Requirement.

VII. MEASURED LOAD

The average kW supplied during the 15-minute period of maximum use during the month, but not less than the minimum kW specified in the Agreement For Service.

Load Measurement, at Company's option, may be made by KVA or thermal type ampere meter, in which case one KVA will be considered equivalent to one kW.

VIII. CONTRACT PERIOD

Not less than one year and extended for one-year periods thereafter.
