**SHORT TERM AND TEMPORARY SERVICE RIDER SCHEDULE ST-17**

---

**I. AVAILABILITY**

At points on existing Facilities having adequate capacity and suitable voltage for delivery of service. The supplying of such service at any point of delivery in no way shall obligate the Company to leave in place any facilities temporarily installed, to supply service after a period of discontinuance of use, to extend or renew any service agreement, to furnish additional service at such point of delivery, or to furnish service to any other point of delivery, each application for service and period of use being a separate transaction determined by availability of capacity at the time and the location, and by the need for temporary facilities.

**II. APPLICATION**

To electric service billed under the General Lighting and Power (GS) rate schedule where Customer's use of service is temporary in nature or is for a term of less than that specified in the rate schedule and the Agreement For Service.

Customer will, upon request by Company, curtail his use of service at times of peak load on Company's system to the extent and during the hours specified by Company from time to time on not less than 48 hours' notice, but such curtailment will not be required for more than 10 hours in any one day.

Not applicable to standby or supplementary service.

All provisions of Company's applicable rate schedules apply, except as modified herein.

**III. BILLING**

In accordance with the terms of the applicable rate schedule except the Minimum Monthly Bill shall not be less than \$2.98 per kW based on the maximum kW specified in the Agreement For Service or the highest kW previously established, whichever is greater, and the total billing shall be at least \$53.10 for each period the meter is installed.

Bills will be prorated for a period of less than one month only at the beginning and on termination of the Service Agreement. The minimum billing period is one month.

**IV. CONNECTION COST**

Customer will pay Company in advance of construction the estimated gross cost of providing, installing, and removing the temporary facilities required to deliver service less the estimated salvage value of such facilities on removal. When the use of service is discontinued or the Service Agreement is terminated, Company will dismantle such facilities, and the materials and equipment temporarily provided by Company will be salvaged by Company and will remain its property.

**V. CONTRACT PERIOD**

Continuously from month to month until discontinuance of use by Customer or termination of the Service Agreement.

**VI. BREAKDOWN SERVICE**

Breakdown Service will be supplied under this Rider Schedule only, and only in event and for the duration of an emergency breakdown in lines or equipment affecting Customer's normal source of power supply.
